Minutes:

Minutes were not available for the April or May 2016 membership meeting

Treasurer's report:

Treasurer Myles Lee reported that there was \$10,469 in the General Fund, \$3,687 in the Scholarship fund for 2017, \$1,000 remaining in the 2016 fund that Tyler Fashempour had not yet spent for lessons, and \$724 in the Young Aviators fund.

Scholarship:

The Scholarship Committee is still looking for another member to help on the committee.

Progress Reports:

Gary Gregory reported on work on his Kitfox

Cliff Goldstein said that he was still waiting for his XP-400 engine for the RV-14

Steve Paschke continues work on his Adventure 333

Trip Reports:

Cliff Goldstein flew to Cleveland, Ohio with his Bonanza

Safety Reports:

Stephanie Wells gave a briefing on some aspects of flying into small airports for the first time and mountain flying. She suggested calling the FBO or airport manager to find out any particular hazards or procedures before heading out to a new airport. Stephanie's recent trip to North Fork Valley airport, 7V2, was discussed along with the need to takeoff downhill on sloping runways. Those who were not current in mountain flying techniques were encouraged to take a mountain flying course.

Young Eagles:

Cliff Hasenbalg reported that there were 12 kids signed up for the June 19th event and 22 for the August event. No YE event is planned for July 19th because of conflict with AirVenture. Cliff is now having the sign-up period for YE flights extend three months into the future. Previously, the full year signup period resulted in many parents forgetting that they had signed up for the event.

Young Aviators:

Scott Serani reported that the Young Aviators have a very busy two months ahead of them. Current activities include work on the trailer for the B-25 loading and lifting mechanism. Scheduled events that they will attend with the B-25 and simulators include:

June 18th - Pueblo Weisbrod Air Museum
 June 25th - Longmont Airport Expo
 July 7th - US Air Force Academy
 July 24th -31st EAA AirVenture
 August 13th - Erie Air Fair

Scott also said that he had received a call from a young man from the Poudre River Association who had seen the Young Aviators' B-25 project online and wanted more information on it. He indicated that their group was interested in building a B-17 nose section.

Flight Advisors and Technical Councilors:

Bill Mitchell provided tech counseling on two airplanes.

Old Business:

Some people are having trouble receiving their certificate for the Youth Protection Policy training. Ken Scott will contact EAA National to find out what the problem is.

New Business:

Longmont Airport Expo – We still need two volunteers to help with the EAA booth.

KidVenture – Steve Beach indicated that Youth Protection Policy Training will not be required to work at KidVenture this July. Volunteers are still need for rib building.

Bill Mitchell wanted to know if anyone was interested in Chapter 43 jackets.

Stephanie Wells indicated that there was a ¼ interest available in a C-182 for \$16,000.

Program:

Steve Paschke talked to us about an inexpensive ADS-B in device.

Next Month's Program:

Phil Brown will be talking about his Pober Pixie that he has built. The plane will also be present at Metro for us to look at.

There was no further business and President Ken Scott adjourned the meeting at 7:40 PM.
